If such purchase is consummated, General Atlantic Partners 82, L.P., General Atlantic Partners 80, L.P., GapStar, LLC, GAP Coinvestments III, LLC, GAP Coinvestments IV, LLC, the reporting person and GAPCO GmbH & Co. KG will own in excess of 10% of the outstanding shares of common stock of the issuer.
