- (1) As of the date of this report, the reporting person also had an indirect beneficial ownership interest in 23,776 shares held in trust and 1,615 shares held in a 401(k).  
  
The award vests in increments of 25% on November 1, 2008, 2009, 2010 and 2011 based on the company achieving performance targets related to pre-tax adjusted income divided by revenue and revenue growth for the applicable one-year performance period beginning on October 1 and ending on the September 30 prior to each vesting date.
  - (2) Shares under the option have an exercise price of \$23.3295, which is 103% of the closing price of the company's common stock on the date of grant (\$22.65).
  - (3) The option vests 25% on each of the first, second, third, and fourth anniversary of the grant date and has a term of seven years.
