(the “Company”) announced that Paul Guagliardo (“Guyardo”) would be terminating his employment with the Company to pursue other opportunities, effective December 31, 2017. He has agreed to help effectuate a smooth transition of his responsibilities. The Company will be treating Mr. Guyardo’s resignation as a termination without cause under his employment agreement.

Mr. Guyardo’s responsibilities will be allocated across the existing leadership team and the Company does not anticipate appointing a Chief Commercial Officer in the near future.
