On February 1, 2019, the reporting person became entitled to receive a combination of cash and shares in exchange for 11,200 shares of common stock of Merchants Holding Company ("Merchants") in accordance with the provisions of the Agreement and Plan of Merger (1) between Bank of Commerce Holdings (the "Issuer") and Merchants dated October 4, 2018 (the "Merger Agreement"). The number of shares issuable to the reporting person pursuant to his election under the terms of the Merger Agreement is 26,009 shares of common stock of the Issuer. On the effective date of the Merger, the closing price of the Issuer's common stock was \$10.69 per share.
