As the investment adviser to the Funds, AWM holds sole voting and investment power over 834,319 shares of Common Stock of the Issuer (the Shares) held by QP, 1 Shares held by CAYMAN and 299,179 Shares held by PE. Austin W. Marx (Marxe), David M. Greenhouse (Greenhouse) and Adam C. Stettner (Stettner) are the controlling principals of AWM.
