The notes do not bear interest. The amount that you will be paid on your notes on the stated maturity date (expected to be June 5, 2024) is based on the performance of the EURO STOXX 50[®] Index as measured from the trade date (expected to be May 31, 2019) to and including the determination date (expected to be May 31, 2024).

If the final underlier level on the determination date is greater than the initial underlier level (set on the trade date), the return on your notes will be positive and will equal the participation rate (expected to be between 2.5 and 2.6) times the underlier return.

If the final underlier level declines by up to 25% from the initial underlier level, you will receive the face amount of your notes. If the final underlier level declines by more than 25% from the initial underlier level, the return on your notes will be negative and will equal the underlier return plus 25%.

We refer to the notes we are offering by this pricing supplement as the “offered notes” or the “notes”. Each of the offered notes has the terms described below.
