This Registration Statement covers 19,800,000 additional shares of common stock, par value \$0.01 per share, of Celgene Corporation (the “Registrant” or the “Corporation”) available for issuance pursuant to awards under the Corporation’s 2008 Stock Incentive Plan (Amended and Restated as of April 15, 2015) (the “Plan”). In accordance (1) with Rule 416(a) under the Securities Act of 1933, as amended, this Registration Statement also covers any additional shares of common stock of the Registrant that become issuable pursuant to awards by reason of any stock dividend, stock split, recapitalization or other similar transaction that results in an increase in the number of the outstanding shares of common stock of the Registrant.

Calculated solely for purposes of this offering under Rules 457(c) and 457(h) under the Securities Act of 1933, as (2) amended, on the basis of the average of the high (\$125.99) and low (\$122.10) selling prices per share of common stock of the Registrant on October 30, 2015, as reported on the Nasdaq Global Select Market.

This Registration Statement on Form S-8 is filed by the Registrant to register an additional 19,800,000 shares of common stock, par value \$0.01 per share (the “Common Stock”), of Celgene Corporation (the “Registrant” or the “Corporation”), which may be awarded under the Celgene Corporation 2008 Stock Incentive Plan (Amended and Restated as of April 15, 2015) (the “Plan”) pursuant to an amendment of the Plan approved by the Corporation’s Board of Directors on April 15, 2015, effective and approved by the stockholders of the Registrant on June 17, 2015.
