- (1) These Ordinary Shares are withheld securities to cover tax liabilities incident to the vesting of Restricted Share Units ("RSUs").
- (2) Options granted to the Reporting Person under the Seagate Technology plc 2012 Equity Incentive Plan (the "Plan") are subject to a four-year vesting schedule. Subject to the Reporting Person's continuous employment, one-quarter of the options will vest on September 10, 2019. The remaining options vest in equal monthly installments over the 36 months following September 10, 2019.
- (3) Each RSU represents a contingent right to receive one Ordinary Share of the Issuer.
- (4) The RSUs, originally granted to the Reporting Person under the Plan for 9,950 shares, of which 2,487 have been released, vest as to one-quarter of the shares on September 11, 2018 and each one-year anniversary thereafter.
