EXPLANATORY NOTE

Deregistration of Securities

On October 18, 1996, The Procter & Gamble Company (the "Company") filed a Registration Statement on Form S-8 (File No. 333-14387) registering 150,000 shares of the Company's common stock (without par value) (the "Common Stock") for issuance under the Giorgio Employee Savings Plan. The Company terminated the Giorgio Employee Savings Plan on May 1, 2001. Accordingly, pursuant to the undertakings contained in the Registration Statement to remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the offering, the Company is filing this Post-Effective Amendment No. 2 to the Registration Statement to deregister all remaining shares of Common Stock and plan participation interests registered but unsold or otherwise unissued under the Registration Statement.
