#### TEVA ANNOUNCES TENTATIVE APPROVAL OF FOSPHENYTOIN SODIUM INJECTION

Jerusalem, Israel, November 21, 2004 - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that the U.S. Food and Drug Administration has granted tentative approval for the Company's ANDA for Fosphenytoin Sodium Injection USP, 50 mg PE/mL (PE = phenytoin sodium equivalents). Final approval is expected upon patent expiry on August 5, 2007.

Teva's Fosphenytoin Sodium Injection is the AP-rated generic equivalent of Pfizer's anticonvulsant Cerebyx<sup>&reg</sup> Injection.

The brand product has annual sales of approximately \$62 million.

Teva Pharmaceutical Industries Ltd., headquartered in Israel, is among the top 25 pharmaceutical companies and among the largest generic pharmaceutical companies in the world. The company develops, manufactures and markets generic and innovative human pharmaceuticals and active pharmaceutical ingredients. Close to 90% of Teva`s sales are in North America and Europe.
