Remarks:

On May 5, 2006, Mr. Ward entered into a forward sale agreement (the "Agreement") relating to up to 1,617,530 shares (the "Hedged Value") of the common stock of Chesapeake Energy Corporation (the "Company").

(a) If the closing price of the common stock on May 7, 2007 (the "Settlement Price") is less than or equal to \$28.0553 (the "Hedged Value"), the Settlement Ratio will be equal to the sum of the Hedged Value and the Upside Limit.

(b) If the Settlement Price is greater than the Hedged Value but less than \$42.4625 (the "Upside Limit"), the Settlement Ratio will be equal to the sum of the Hedged Value and the Upside Limit.

(c) If the Settlement Price is equal to or greater than the Upside Limit, the Settlement Ratio will be equal to the sum of the Hedged Value and the Upside Limit.

In consideration therefore, the Agreement provides that Mr. Ward will receive a purchase price of \$53,388,518.69.
