Item 1. Security and Issuer.

This statement relates to the common stock, par value \$4.00 per share (the “Common Stock”), of First Mid-Illinois Bancshares, Inc., a Delaware corporation (the “Company”), whose principal executive offices are located at 1421 Charleston Avenue, Mattoon, Illinois 61938.

Item 2. Identity and Background.

a. Name

This statement is being filed by Ray Anthony Sparks individually.

b. Residence or Business Address

Mr. Sparks’ business address is as follows: 90 Broadway, Po Box 667, Mattoon, IL 61938.

Mr. Sparks’ residence is as follows: 30 South Country Club Rd, Mattoon, IL 61938.

c. Present principal occupation or employment and the name, principal business and address of any corporation or other organization in which such employment is conducted:

Mr. Sparks’ principal occupation is Private investor, Sparks Investment Group LP.

Whether or not during the last five years, any such person has been convicted in a criminal proceeding (excluding d. traffic violations or similar misdemeanors) and, if so, give the dates, nature of conviction, name and location of court, and penalty imposed, or other disposition of the case:

During the last five years, Mr. Sparks has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

Whether or not, during the last five years, such person was a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, e. decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws; and, if so, identify and describe such proceedings and summarize the terms of such judgment, decree or final order:

During the last five years, Mr. Sparks has not been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction resulting in a judgment, decree or final order finding any violation with respect to federal or state securities laws or enjoining future violations of, or prohibiting or mandating activities subject to, such laws.

f. Citizenship

Mr. Sparks is a citizen of the United States of America.

Item 3. Source and Amount of Funds or Other Consideration.

Since Mr. Sparks 13D filing on February 11, 2009, shares of Common Stock for which Mr. Sparks is reporting beneficial ownership herein have been acquired in the following manner: (i) 7,000 shares held by Mr. Sparks individually have been acquired in open market purchases; (ii) 85,568 shares acquired upon the conversion of 370 shares of Series B 9% Non-Cumulative Perpetual Convertible Preferred Stock ("Series B Preferred Stock") of the Company held by Mr. Sparks Individually; (iii) 12,345 shares acquired by Mr. Sparks individually through a private placement offering by the Company on June 19, 2015; (iv) 4,295 shares held for the account of Mr. Sparks have been acquired under the Company's Deferred Compensation Plan; (v) 23,126 shares acquired upon the conversion of 100 shares of Series B Preferred Stock of the Company held by Sparks Investment Group, LP over which Mr. Sparks shares voting and investment power; (vi) Mr. Sparks also had 21,500 shares held individually which were gifted on November 5, 2010; and (vii) 20,000 held by Sparks Investment Group, LP over which Mr. Sparks shares voting and investment power were sold to the Company on December 11, 2012. Mr. Sparks also had 3,375 shares which Mr. Sparks had the right to acquire by exercise of outstanding stock options under the Company's Stock Incentive Plan that reached their 10 year term and expired.

No borrowed funds were used for any of the above listed acquisitions.

Item 4. Purpose of Transaction.

Purchases of shares of Common Stock by Mr. Sparks have been for investment purposes. Mr. Sparks may purchase additional shares from time to time depending upon price, market conditions, availability of funds, evaluation of other investment opportunities, and other factors. Although Mr. Sparks has no present intention to sell any shares, although he could determine from time to time, based upon the same factors listed above for purchases, to sell some or all of the shares held by him.

Except as set forth above, Mr. Sparks does not have any plan or proposal which relates to or would result in any of the following matters:

- (a) The acquisition by any person of additional securities of the issuer, or the disposition of securities of the issuer;
- (b) An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the issuer or any of its subsidiaries;
- (c) A sale or transfer of a material amount of assets of the issuer or of any of its subsidiaries;
- (d) Any change in the present board of directors or management of the issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;
- (e) Any material change in the present capitalization or dividend policy of the issuer;

- (f) Any other material change in the issuer's business or corporate structure;
- (g) Changes in the issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the issuer by any person;
- (h) Causing a class of securities of the issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;
- (i) A class of equity securities of the issuer becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Securities Exchange Act of 1934; or
- (j) Any action similar to any of those enumerated above.

Item 5. Interest in Securities of the Issuer.

- State the aggregate number and percentage of the class of securities identified pursuant to Item 1 (which may be based on the number of securities outstanding as contained in the most recently available filing with the Commission by the issuer unless the filing person has reason to believe such information is not current)
- (a) beneficially owned (identifying those shares which there is a right to acquire) by each person named in Item 2. The above mentioned information should also be furnished with respect to persons who, together with any of the persons named in Item 2, comprise a group with the meaning of Section 13(d)(3) of the Act;

Mr. Sparks' total beneficial ownership amounts to 419,172 shares of Common Stock, or 4.9% of the outstanding shares.

- (b) For each person named in response to paragraph (a), indicate the number as to which there is sole power to vote or to direct the vote, shared power to vote or to direct the vote, sole power to dispose or to direct the disposition, or shared power to dispose or to direct the disposition. Provide the applicable information required by Item 2 with respect to each person with whom the power to vote or to direct the vote or to dispose or direct the disposition is shared;

Mr. Sparks' holds sole voting and investment power over the following shares of Common Stock: (i) 228,645 shares held individually, (ii) 23,499 shares held for the account of Mr. Sparks under the Company's Deferred Compensation Plan; and (iii) 220 shares of Series C 8% Non-Cumulative Perpetual Convertible Preferred Stock ("Series C Preferred Stock") of the Company, which are convertible into 54,213 shares of Common Stock of the Company, held by Mr. Sparks individually.

Mr. Sparks also holds shared voting and investment power over the following shares of Common Stock: (i) 89,649 shares held by Sparks Investment Group, LP; (ii) 18,880 shares held by the Sparks Foundation; (iii) 1,822 shares held by Mr. Sparks' child; and (iv) 10 shares of Series C Preferred Stock, which is convertible into 2,464 shares of Common Stock of the Company.

- (c) Describe any transactions in the class of securities reported on that were effected during the past sixty days or since the most recent filing of Schedule 13D, whichever is less, by the persons named in response to paragraph (a).

During the past 60 days, Mr. Sparks has effected no transactions in the Common Stock of the Company other than the following:

- (i) On June 19, 2015, Mr. Sparks acquired 12,345 shares of Common Stock through a private placement offering by the Company. The price per share was \$21.00.

Other than the entities described in sub-items (a) & (b) above, to the knowledge of Mr. Sparks, no other person has (d) the right to receive or the power to direct the receipt of dividends from, or proceeds from the sale of, the shares of Common Stock beneficially owned by Mr. Sparks.

(e) Not applicable.

Item 6. Contracts, Arrangements, Understandings or Relationships With Respect to Securities of the Issuer.

There are no contracts, arrangements, understandings or relationships (legal or otherwise) between Mr. Grissom and any person with respect to any securities of the issuer.
