Item 1(a): Name of Issuer:

The name of the issuer is Motorcar Parts of America, Inc., a corporation organized under the laws of the State of New York (the "Company").

Item 1(b): Address of Issuer's Principal Executive Offices:

adviser to a variety of hedge funds and managed accounts (such funds and accounts, collectively, the "Funds"), with respect to shares of Common Stock (as defined in Item 2(d)) directly owned by the Funds and shares of Common Stock issuable upon the exercise of warrants directly owned by the Funds; and

- (ii) Mr. Daniel S. Loeb ("Mr. Loeb"), who is the Chief Executive Officer of the Management Company and controls its business activities, with respect to shares of Common Stock indirectly beneficially owned by Mr. Loeb by virtue of such position and shares of Common Stock issuable upon the exercise of warrants indirectly beneficially owned by Mr. Loeb by virtue of such position.

- (iii) Third Point Offshore Fund, Ltd., a Cayman Islands limited liability exempted company (the "Offshore Fund") which invests and trades in securities, with respect to shares of Common Stock directly held by it and shares of Common Stock issuable upon the exercise of warrants held by it.

The Management Company, Mr. Loeb and the Offshore Fund are hereinafter sometimes collectively referred to as the "Reporting Persons." Any disclosures herein with respect to persons other than the Reporting persons are made on information and belief after making inquiry to the appropriate party.
