("SCLMF"), Saba Capital Partners (Cayman), L.P., ("SCP") and Saba Capital Series LLC Series 1 ("SCS").<sup>[2]</sup>

The Reporting Persons have entered into a Joint Filing Agreement, dated February 17, 2015 pursuant to which the Reporting Persons have agreed to file this statement and any subsequent amendments thereto jointly in accordance with the provisions of Rule 13d-1(k)(1) under the Act.
