On November 15, 2010, the common stock of A. O. Smith Corporation split 3-for-2, resulting in 5,991 additional shares of Common Stock. On May 15, 2013, the common stock of A. O. Smith Corporation split 2-for1, resulting in the reporting person's ownership of 17,974 additional shares of Common Stock.

On May 15, 2013, the common stock of A. O. Smith Corporation split 2-for1, resulting in the reporting person's ownership of 8,287 additional Restricted Stock Units. The Restricted Stock Units receive a quarterly dividend pursuant to a dividend reinvestment feature of the A. O. Smith Nonqualified Deferred Compensation Plan. The total amount of dividends received was 53 Restricted Stock Units.
