As of the close of business on the date hereof, (i) BVF beneficially owned 170,453 shares of Common Stock, (ii) BVF2 beneficially owned 88,372 shares of Common Stock, (iii) BVLLC beneficially owned 1,040,859 shares of Common Stock, (iv) ILL10 beneficially owned 47,663 shares of Common Stock, and (v) MSI beneficially owned 61,252 shares of Common Stock.

Partners, as the general partner of BVF and BVF2, the manager of BVLLC, and the investment adviser of each of ILL10 and MSI, may be deemed to beneficially own the 1,408,599 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, BVLLC, ILL10 and MSI.
