The following constitutes Amendment No. 4 to the Schedule 13D filed by the undersigned (“Amendment No. 4”). This Amendment No. 4 amends the Schedule 13D as specifically set forth herein.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 is hereby amended and restated to read as follows:

The Shares and call options purchased by each of the Master Fund and the Canadian Fund, and the Shares and call options held in the Separately Managed Accounts, were purchased with working capital (which may, at any given time, include margin loans made by brokerage firms in the ordinary course of business). The aggregate purchase price of the 1,000,413 Shares owned directly by the Master Fund is approximately \$27,192,596, including brokerage commissions. The aggregate purchase price of the call options exercisable into 17,700 Shares owned directly by the Master Fund is approximately \$11,543, including brokerage commissions. The aggregate purchase price of the 89,864 Shares owned directly by the Canadian Fund is approximately \$2,462,910, including brokerage commissions. The aggregate purchase price of the call options exercisable into 1,600 Shares owned directly by the Canadian Fund is approximately \$1,047, including brokerage commissions. The aggregate purchase price of the 562,823 Shares held in the Separately Managed Accounts is approximately \$15,412,378, including brokerage commissions. The aggregate purchase price of the call options exercisable into 10,100 Shares held in the Separately Managed Accounts is approximately \$7,123, including brokerage commissions.

Item 4. Purpose of Transaction.

Item 4 is hereby amended to add the following:

On June 3, 2015, David A. Lorber resigned from the Issuer’s Board of Directors (the “Board”) in light of the Issuer’s announced acquisition on June 1, 2015, the same date that Mr. Lorber was elected to the Board, by funds managed by affiliates of Apollo Global Management, LLC for \$34.00 per Share in cash. Pursuant to the Settlement Agreement by and among FrontFour Capital and certain of its affiliates (“FrontFour”) and the Issuer, dated March 23, 2015, FrontFour has notified the Issuer that it intends to exercise its right to identify a replacement director, who shall qualify as “independent” pursuant to New York Stock Exchange listing standards and the Issuer’s Corporate Governance Principles, and have relevant financial and business experience, to fill the resulting vacancy on the Board.

Item 5. Interest in Securities of the Issuer.

Items 5(a) – (c) are hereby amended and restated to read as follows:

(a) The aggregate percentage of Shares reported owned by each person named herein is based upon 30,738,083 Shares outstanding as of May 26, 2015, which is the total number of Shares outstanding as reported in Exhibit 2.1 to the Issuer’s Current Report on Form 8-K filed with the Securities and Exchange Commission on June 1, 2015.

As of the close of business on June 4, 2015, the Master Fund beneficially owned directly 1,018,113 Shares (including 17,700 Shares underlying certain call options exercisable within 60 days of the date hereof), the Canadian Fund beneficially owned directly 91,464 Shares (including 1,600 Shares underlying certain call options exercisable within 60 days of the date hereof), and 572,923 Shares (including 10,100 Shares underlying certain call options exercisable within 60 days of the date hereof) were held in the Separately Managed Accounts, constituting approximately 3.3%, less than 1%, and approximately 1.9%, respectively, of the Shares outstanding.

FrontFour Capital, as the investment manager of the Master Fund and the Separately Managed Accounts, may be deemed to beneficially own the 1,591,036 Shares directly beneficially owned in the aggregate by the Master Fund and held in the Separately Managed Accounts, constituting approximately 5.2% of the Shares outstanding.

FrontFour Corp., as the investment manager of the Canadian Fund, may be deemed to beneficially own the 91,464 Shares directly beneficially owned by the Canadian Fund, constituting less than 1% of the Shares outstanding.

Each of Messrs. Loukas, Lorber and George, as a managing member and principal owner of FrontFour Capital and a principal owner of FrontFour Corp., may be deemed to beneficially own the 1,682,500 Shares directly beneficially owned in the aggregate by the Master Fund and the Canadian Fund and held in the Separately Managed Accounts, constituting approximately 5.5% of the Shares outstanding.

Each of the Reporting Persons, as a member of a “group” with the other Reporting Persons for purposes of Rule 13d-5(b)(1) of the Securities Exchange Act of 1934, as amended (the “Exchange Act”), may be deemed to beneficially own the securities of the Issuer owned by the other Reporting Persons. The filing of this Schedule 13D shall not be deemed an admission that the Reporting Persons are, for purposes of Section 13(d) of the Exchange Act, the beneficial owners of any securities of the Issuer he or it does not directly own. Each of the Reporting Persons specifically disclaims beneficial ownership of the securities reported herein that he or it does not directly own.

(b) Each of the Master Fund, FrontFour Capital and Messrs. Loukas, Lorber and George have shared power to vote or direct the vote of, and to dispose or direct the disposition of, the Shares owned directly by the Master Fund.

Each of FrontFour Capital and Messrs. Loukas, Lorber and George have shared power to vote or direct the vote of, and to dispose or direct the disposition of, the Shares held in the Separately Managed Accounts.

Each of the Canadian Fund, FrontFour Corp. and Messrs. Loukas, Lorber and George have shared power to vote or direct the vote of, and to dispose or direct the disposition of, the Shares owned directly by the Canadian Fund.

(c) The transactions in the securities of the Issuer by the Reporting Persons during the past sixty days are set forth in Schedule A and are incorporated herein by reference.
