## INFORMATION REQUIRED IN REGISTRATION STATEMENT

### Item 1. Description of Registrant's Securities to be Registered

The classes of securities registered hereby consist of (i) the Trust Preferred Securities (the "Trust Preferred Securities") representing preferred undivided beneficial interests in the assets of Colonial Capital Trust III, a statutory business trust formed under the laws of the State of Delaware (the "Trust") and (ii) the Trust Preferred Securities Guarantee with respect thereto (the "Guarantee") by The Colonial BancGroup, Inc. (the "Company").

For a description of the Trust Preferred Securities and the Guarantee, reference is made to the information set forth under the headings: (a) "Description of Preferred Securities" and "Description of Preferred Securities Guarantees" in the prospectus relating to the Trust Preferred Securities and the Guarantee contained in the Registration Statement on Form S-3 (Registration Nos. 333-83390 and 333-83390-01) filed with the Securities and Exchange Commission (the "Commission") on February 26, 2002, and amended by Pre-Effective Amendment No. 1 filed with Commission on March 11, 2002, under the Securities Act of 1933, as amended (the "Act") (such Registration Statement being hereinafter referred to as the "Registration Statement"), and (b) "Description of the Preferred Securities" and "Description of the Preferred Securities Guarantee" in the final prospectus which was filed pursuant to Rule 424(b) of the Act on March 18, 2002. The above mentioned descriptions contained in the Registration Statement and the prospectus are incorporated herein by reference.
