On February 3, 2003, a Form 4 was mistakenly filed for the reporting person, reporting a gift of 1,925 shares from the reporting person to a limited liability company (LLC) owned by the reporting person and the reporting person's spouse and indicating the form of ownership (1) of the shares as indirect.
