Advisors, pursuant to its authority under its investment advisory contract with Associates, may be considered to hold indirectly 32,700 shares of Common Stock and Capital, pursuant to its authority as general partner of Caduceus, may be considered to hold indirectly 3,415,300 shares of Common Stock.
