Capital Group International, Inc. ("CGII") is the parent holding company of a group of investment management companies that hold investment power and, in some cases, voting power over the securities reported in this Schedule 13G. The investment management companies, which include a "bank" as defined in Section 3(a)(6) of the Securities Exchange Act of 1934 (the "Act") and several investment advisers registered under Section 203 of the Investment Advisers Act of 1940, provide investment advisory and management services for their respective clients which include registered investment companies and institutional accounts. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 193,000 shares or 1.1% of the 17,885,000 shares of American Depositary Shares, representing Class A Ordinary Shares believed to be outstanding.

Capital International, Inc. ("CII"), an investment adviser registered under Section 203 of the Investment Advisers Act of 1940 is deemed to be the beneficial owner of 187,200 shares or 1% of the 17,885,000 shares of American Depositary Shares, representing Class A Ordinary Shares believed to be outstanding as a result of acting as investment adviser to various investment companies and institutional accounts.

All of the shares reported are held in the form of American Depositary Shares, which each represent 2 Class A Ordinary Shares.
