By order dated May 20, 2005 and received by the Company on May 25, 2005, Judge Ronald M. Whyte denied without prejudice preliminary approval of the previously announced proposed settlement of the consolidated class action pending in the U.S. District Court for the Northern District of California. The order expressed the court's objection to two non-monetary provisions of the settlement.
