The Trust Shares represent a beneficial interest in the Carnival plc special voting share.

- (3) The prices included on this form represent the sales price for the paired Trust Shares and shares of Carnival Corporation Common Stock.
- (4) These shares were sold pursuant to a Rule 10b5-1(c) sales plan dated October 24, 2007.
