**Item 8.01 Other Events.**

On December 29, 2005, LHC Group, Inc. (the Company ) issued a press release announcing its intention to acquire a 67% ownership interest in Infirmity Home Health ( Infirmity ), a leading provider of home health care services in southwestern Alabama.

The transaction is expected to be completed in early February 2006. Infirmity, a subsidiary of Infirmity Health Systems based in Mobile, Alabama, is expected to report approximately \$8 million in annual revenue for the 2005 fiscal year. Infirmity currently operates two home health care agencies in Alabama, one based in Mobile County and another based in Clark County. The terms of the transaction were undisclosed in accordance with the Company s agreement with Infirmity.
