# Item 2.01 Completion of Acquisition or Disposition of Assets.

As previously reported on Form 8-K filed with the Securities and Exchange Commission on July 6, 2007, Agilysys, Inc. and its wholly-owned subsidiary, Agilysys NJ, Inc. (the Company ), completed the acquisition of Innovative Systems Design, Inc. (d/b/a Innovativ Systems Design, Inc.)
